PROCEDURAL ORDER

BY THE COMMISSION:

September 10, 2002, the Commission issued Decision No. 65154 in these consolidated dockets. Decision No. 65154 ordered Arizona Public Service Company ("APS") and Tucson Electric Power Company ("TEP") to submit modifications to their existing Codes of Conduct.

On November 12, 2002, APS filed modifications to its Code of Conduct. Also on November 12, 2002, TEP filed a letter with the Commission stating that neither TEP nor its parent, UniSource Energy, has a competitive electric service provider, a separate generation affiliate, or an affiliate involved in the marketing and trading of wholesale power.

On March 14, 2003, the Commission issued Decision No. 65743 in these consolidated dockets. Decision No. 65743 directed the Commission's Utilities Division Staff ("Staff") to file

1 reports in these dockets on the Codes of Conduct previously filed by APS and TEP, within 60 days of
2 the Independent Monitor's final reports. Decision No. 65743 stated that the Staff Reports should
3 include, but not be limited to, an analysis of the Standards of Conduct developed for the Track B
4 solicitations, their applicability to the respective Codes of Conduct filed by APS and TEP, and
5 recommendations regarding their incorporation into the Codes of Conduct. Decision No. 65743
6 provided that hearings would be scheduled on the Codes of Conduct following the filing of those
7 Staff Reports.

8 Staff filed a Staff Report in these dockets on August 13, 2003.

9 A Procedural Order was issued scheduling a Procedural Conference for October 3, 2003, for
10 the purpose of discussing the procedural schedule for hearings on the APS and TEP Codes of
11 Conduct. The Procedural Conference was convened as scheduled. APS, TEP, Panda Gila River,
12 LLP, the Arizona Utilities Investors Association, the Residential Utility Consumer Office and Staff
13 entered appearances.

14 On October 3, 2000, following the Procedural Conference, a Procedural Order was issued that
15 adopted the parties' recommendation that a hearing should be scheduled on the proposed
16 modifications to APS' Code of Conduct following the conclusion of the APS rate case pending in
17 Docket No. E-01345A-03-0437.

18 On April 7, 2003, the Commission issued Decision No. 67744 in APS' rate case docket.

19 Accordingly, a procedural conference should be held to discuss procedural matters relating to
20 the hearing on the proposed modifications to APS' Code of Conduct.

5 timeframes for discovery, the filing of an update to the Staff Report, and any prefiled testimony.


