

I received a copy of letter directed to Commissioner Spitzer of the Arizona Corporation Commission, dated May 20, 2002. We investigated the concerns that you expressed in that letter in light of the policy and practices that Qwest has adopted to protect its customers' privacy.

Your second residential line, which you refer to as a "Silent Line" in your letter, does not have any listing associated with the telephone number. Because that telephone number is billed with your first residential line, the second number does not appear anywhere in the phone book or directory assistance. As a result, Qwest would not have provided that information to directory publishers or directory assistance providers (businesses that have a right to certain customer name, address, and telephone number information). Nor would Qwest have provided such information to a telemarketing firm acting on its behalf.

You claim that Qwest has been selling blocks of telephone numbers assigned to customers to telemarketing firms. This is not the case. Perhaps what is happening is that you were called by a telemarketer that uses an "auto-dialer". Telemarketing firms often utilize systems that dial all possible number combinations until a call is answered. Once that call is answered, the call is instantly directed to a live marketer or, if no operator is available, the line is disconnected. In the alternative, another business entity with which you had contact may have secured your second number and passed it on to other companies.

You also seem to believe that there is a charge associated with a listing for your "Silent Line". This is incorrect. Qwest does not charge you any additional amount to maintain a listing for that line. The service is free because the Silent Line is connected to the same account as your published primary line. If you would like us to review your charges with you or discuss any further concerns, please call us.



There are many stories these days about the financial woes with QWEST! You have probably read some of the same articles I have seen -- in THE ARIZONA REPUBLIC as well as THE WALL STREET JOURNAL....

There is now another development you may want to know more about. It has to do with the apparent selling of blocks of telephone numbers -- to telemarketing firms -- by QWEST ... including every SILENT NUMBER that may be in that batch of numbers!

I have been paying for a silent number for nearly 14 years. All this in addition to our listed number. And only in the past month has this silent number STARTED RINGING several times a day.

To verify my suspicions, I answered the call twice -- and I discovered both were telemarketers. One was trying to sell homes ... the other caller spoke such broken English I could not tell what in the world he was trying to sell.

If one pays for a silent number, that person should NOT be bothered by constant calls from telemarketers. But QWEST is apparently trying to make a fast buck by selling silent numbers to telemarketers or, I suppose, to anyone who wants to give them some money.

From all I have heard about you, I find it very unlikely that you would have condoned such activities when you were in the Arizona Legislature. And I am hoping you will not favor such activities now, either!
