PROCEDURAL ORDER

BY THE COMMISSION:

On February 9, 2005, Cave Creek Water Company ("Company" or "Applicant"), filed an application for an extension of its Certificate of Convenience and Necessity ("Certificate") with the Arizona Corporation Commission ("Commission") to provide public water utility service to various parts of Maricopa County, Arizona.

In accordance with A.R.S. § 41-1074(C), the application herein was deemed administratively complete.

On March 15, 2005, by Procedural Order, pursuant to A.A.C. R14-3-101, the Commission ordered the Utilities Division ("Staff") to file the Staff Report by April 19, 2005, and scheduled a hearing to commence on May 5, 2005. Other procedural dates were also established.

On April 4, 2005, Applicant filed certification of public notice.

On April 21, 2005, Staff filed what was captioned "Request for Extension" ("Motion") which requests a retroactive extension of the filing date on which the Staff Report is due because Staff needs until June 7, 2005 to secure additional information to prepare its report. Staff further requests that the hearing be continued consistent with the extension of time needed to file the Staff Report and that the time frame be suspended. Staff indicates that the Company is in agreement with its Motion.

Accordingly, Staff's Motion should be granted, the filing dates extended, the evidentiary portion of the proceeding continued and the time frame suspended.

IT IS THEREFORE ORDERED that the hearing scheduled on May 5, 2005, at 9:30 a.m., at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona shall be held for taking

1 public comment only.

2 IT IS FURTHER ORDERED that the evidentiary portion of the proceeding shall be continued
3 form May 5, 2005 to June 28, 2005 at 9:30 a.m.,

4 IT IS FURTHER ORDERED that the Staff Report and associated exhibits to be presented at
5 hearing on behalf of Staff shall be reduced to writing and filed on or before 4:00 p.m. on June 7,
6 2005.

7 IT IS FURTHER ORDERED that any objections to the Staff Report and associated exhibits
8 to be presented at hearing by Applicant shall be reduced to writing and filed on or before 4:00 p.m.
9 on June 14, 2005.

10 IT IS FURTHER ORDERED that intervention shall be in accordance with A.A.C. R14-3-105,
11 except that the time for filing all motions to intervene shall be extended to June 1, 2005.

12 IT IS FURTHER ORDERED that the time frame shall be suspended until further Order.

13 IT IS FURTHER ORDERED that the presiding Administrative Law Judge may rescind, alter,
14 amend, or waive any portion of this Procedural Order either by subsequent Procedural Order or by
15 ruling at hearing.


