

## CUSTOMER NOTICE

### Change in Rates for Wastewater Service

Dear Utility Customer:

You are receiving this Public Notice because you have previously received wastewater utility service from Arizona Utility Supply & Services, L.L.C. ("AUSS"). AUSS filed a Chapter 7 bankruptcy petition on August 4, 2004. On February 18, 2005, the Arizona Corporation Commission ("Commission") issued Decision No. 67586, which grants an application for the transfer of AUSS' assets and service area to Johnson Utilities Company ("JUC") upon fulfillment of certain conditions. A copy of this Decision is on file with the Commission.

JUC's Commission-approved tariffed rate for residential wastewater utility service is \$38.50 per month – \$8.50 more than the \$30.00 per month AUSS rate. Upon the Commission's final approval authorizing the transfer of AUSS' assets and service area to JUC, you will become a permanent JUC wastewater customer subject to the \$38.50 monthly fee. **YOUR RATES WILL NOT CHANGE UNTIL THE COMMISSION ISSUES A FINAL ORDER IN THIS MATTER.** JUC is confident that this increased cost will be mirrored by a higher level of customer support and service. Further, the transfer will greatly reduce and eliminate the numerous health and safety related concerns generated over the past eighteen (18) months.
