REQUEST FOR ADDITIONAL TIME TO  
COMPLY WITH FILING REQUIREMENT

On July 25, 2000 the Commission entered Decision No. 62754 in the above-captioned docket. Decision No. 62754 approved the Company's application for a new certificate of convenience and necessity for its Oracle system. It also ordered the Company to file a copy of the SaddleBrooke Ranch developer's Certificate of Assured Water Supply within five (5) years from the effective date of said Decision.

Robson Communities, the developer of the SaddleBrooke Ranch development, has informed the Company that, due to unexpected delays in planning and financing for its development, it will not be ready to proceed with development until at least early 2006. For this reason, the Company requests that it be given an additional 365 days, until July 25, 2006 to file a copy of the certificate of assured water supply. This request should not prejudice any other party, as the Company was the only applicant for a certificate of convenience and necessity for the expansion area.
