On October 7, 2004, Valley Utilities Water Company, Inc. ("Valley Utilities") filed an application with the Arizona Corporation Commission ("Commission") for an increase in its water rates for customers within Maricopa County, Arizona.

On December 7, 2004, by Procedural Order, a hearing was set in the rate case for July 14, 2005.

By Procedural Order issued March 23, 2005, the above-captioned financing application was consolidated with the rate application for purposes of hearing.
