PROCEDURAL ORDER

BY THE COMMISSION:

On January 20, 2005, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Temporary Order to Cease and Desist ("T.O.") and a Notice of Opportunity for Hearing ("Notice") against Centenarios Gold Inc. ("CGI"), Tim and Jane Doe Watt (collectively the "Respondents") in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of stock.

Respondents were duly served with a copy of the T.O. and the Notice.

On April 6, 2005, Respondents filed an Answer and request for a hearing.

On April 8, 2005, by Procedural Order, a pre-hearing conference was scheduled to address the issues raised by the T.O. and Notice on May 10, 2005.

On May 10, 2005, at the pre-hearing conference, the Division appeared through counsel and Respondent, Tim Watt, appeared on his own behalf. Since the parties were unable to resolve the issues raised in the T.O. and Notice, it was agreed that a hearing should be scheduled.

Accordingly, a hearing should be held on the allegations contained in the T.O. and Notice.




