PROCEDURAL ORDER

BY THE COMMISSION:

On February 17, 2005, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Temporary Order to Cease and Desist ("T.O.") and a Notice of Opportunity for Hearing ("Notice") against MGN Enterprises, Inc. ("MGN"), John S. Mendibles (collectively the "Respondents") in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of investment contracts.

Respondents were duly served with a copy of the T.O. and the Notice.

On April 4, 2005, Respondents filed an Answer and request for a hearing.

On April 6, 2005, by Procedural Order, a pre-hearing conference was scheduled for May 10, 2005.

On May 10, 2005, at the pre-hearing conference, the Division appeared through counsel. Respondents did not appear and the Division indicated that a hearing should be scheduled.

Accordingly, a hearing should be held on the allegations contained in the T.O. and Notice.

1 IT IS THEREFORE ORDERED that a **hearing** shall be held on **June 21, 2005, at 10:00**
2 **a.m.**, at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona.

3 IT IS FURTHER ORDERED that the parties shall set aside **June 22, 2005** for an additional
4 day of **hearing**, if necessary.

5 IT IS FURTHER ORDERED that the parties shall exchange copies of their exhibits and
6 witness lists by June 7, 2005, with courtesy copies provided concurrently therewith to the presiding
7 Administrative Law Judge.
