 10 Baseline Road, Suite 105 Tempe, Arizona 85283, by his inclusion in the notice being mailed to
 11 Maria Elena Gonzalez, a named Respondent in this action. The notice was returned by the United
 12 States Postal Service, not delivered and marked Attempted not known. The above Respondent was
 13 not listed on the rental agreement for the mail box. The above Respondent had not expressly
 14 authorized Mail Boxes and More to accept certified mail on his behalf. The address of 455 N.
 15 County Club Drive, Mesa Arizona 85201 was the last known employment address for Maria Elena
 16 Gonzalez. Maria Elena Gonzales ceased employment at this address over one year prior to the
 17 service of this notice.


