FINDINGS OF FACT

1. Cox Arizona Telcom, LLC ("Cox") is certificated to provide telecommunications services in the State of Arizona.
2. On May 17, 2005, Cox filed an application for an extension of the complete waiver of Public Utility Holding Companies and Affiliated Interests Rules, Arizona Administrative Code ("A.A.C.") R 14-2-805 that was granted to Cox in Decision No. 66234, dated September 16, 2003.
3. Staff has not completed its evaluation of the application and, therefore, recommends that the filing be suspended for a period of one hundred twenty (120) days.

CONCLUSIONS OF LAW

1. Cox is an Arizona public service corporation within the meaning of Article XV, Section 2, of the Arizona Constitution.
2. The Commission has jurisdiction over Cox and of the subject matter in this filing.
