
**MOTION TO AMEND THE

6 Staff of the Utilities Division ("Staff") of the Arizona Corporation Commission
7 ("Commission") respectfully requests to amend the Procedural Order issued June 6, 2003 for the
8 reason that certain dates from the original Procedural Order issued March 14, 2003 were not changed
9 in accordance with the new procedural schedule. Those dates are as follows:

- 10 1. The date when any objections to any testimony or exhibits were to be filed; the current
11 date being October 9, 2003 (See Procedural Order of March 14, 2003, p. 3, lines 15
12 through 17).
- 13 2. The date when all discovery requests are to cease, the current date being October 20,
14 2003 (Id., p. 4, lines 10 through 11).

15 Staff would recommend changing the above dates such that they are in accordance with the
16 other dates in the Procedural Order issued June 6, 2003. Staff has contacted all of the other
17 intervenors in this case and all have indicated that they do not have an objection to the above request.


