PROCEDURAL ORDER

BY THE COMMISSION:

On February 9, 2005, Cave Creek Water Company ("Company" or "Applicant"), filed an application for an extension of its Certificate of Convenience and Necessity ("Certificate") with the Arizona Corporation Commission ("Commission") to provide public water utility service to various parts of Maricopa County, Arizona.

On April 22, 2005, by Procedural Order, the evidentiary portion of the proceeding was continued to June 8, 2005, at 9:30 a.m., at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona.

On April 26, 2005, the Town of Cave Creek ("Town") filed an Application to Intervene. There has been no opposition to the Application.

Accordingly, Town's Motion should be granted, and it may participate in the proceeding.

IT IS THEREFORE ORDERED that the Application to Intervene by the Town of Cave Creek is hereby granted.

IT IS FURTHER ORDERED that the presiding Administrative Law Judge may rescind, alter, amend, or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


