PROCEDURAL ORDER

BY THE COMMISSION:

On November 19, 2005, Oak Creek Utility Corporation ("Oak Creek") filed with the Arizona Corporation Commission ("Commission") an application for authority to issue promissory note(s) and other evidences of indebtedness in Docket No. WS-02061A-04-0836. Concurrently, Oak Creek filed an application for a rate increase in Docket No. WS-02061A-04-0835.

On March 17, 2005, Oak Creek filed a Motion to Consolidate the above-captioned dockets. Oak Creek contends that both applications will consider related law and facts, have the same witnesses, and are inter-related. No party filed a response in opposition to Oak Creek's request.

These cases are substantially related, and the rights of the parties will not be prejudiced by consolidation. Therefore, Oak Creek's Motion to Consolidate is reasonable and shall be granted.

IT IS THEREFORE ORDERED that Oak Creek Utility Corporation's Motion to Consolidate is hereby granted.
