Application of Arizona Public Service Company for Leave to Intervene

Pursuant to A.A.C. R-14-3-105 and for the reasons that follow, Arizona Public Service Company (APS) respectfully applies for an Order granting APS leave to intervene in the above-captioned proceeding:

1. APS is a public service corporation within the contemplation of § 2 of Article XV of the Arizona Constitution, and APS is certificated by the Commission to provide electric service in that capacity throughout various areas within the state of Arizona;

2. APS maintains facilities and operations within portions of the state of Arizona in which Southwest Gas Corporation (Southwest) is authorized by the Commission to provide natural gas service, and APS receives natural gas service as a customer of Southwest. As a customer of Southwest, APS has a direct and substantial interest in the terms and conditions, including the rates and charges, under which Southwest provides natural gas service; and

3. APS' intervention would not result in having the issues in the above-captioned proceeding unduly broadened for the reason that APS' participation would be limited solely to issues bearing directly on the Application filed by Southwest in the above-captioned proceeding.
