**BY THE COMMISSION:**

On April 25, 2005, Arizona Corporation Commission Staff ("Staff") filed the testimony of Elijah O. Abinah in support of a settlement reached in the above captioned matter.

On April 27, 2005, Staff docketed a letter indicating that the April 25, 2005 testimony inadvertently contained confidential information. Staff requested that it be allowed to withdraw the April 25, 2005 testimony and file redacted testimony in the public record in its place.

Pursuant to A.R.S. § 40-204, the testimony containing confidential information should be withdrawn from the Commission's Docket Control and Staff should substitute redacted testimony in its place.

IT IS THEREFORE ORDERED that Docket Control and all parties who have not signed a confidentiality agreement in this case and who received the April 25, 2005 testimony of Elijah O. Abinah, shall either destroy it or return such testimony to Staff.
