PROCEDURAL ORDER

BY THE COMMISSION:

On March 14, 2005, Naco Water Co., LLC ("NWC" or "Company") filed an application for approval of an emergency increase in its rates.

By Procedural Order dated March 25, 2005, the matter was set for hearing on May 10, 2005, at the Arizona Corporation Commission's ("Commission") offices in Tucson, Arizona.

On March 31, 2005, NWC mailed notice of the hearing to all of its customers.

On April 21, 2005, residents of the areas served by NWC filed a Petition signed by approximately 88 individuals with the Commission requesting that the hearing be held on May 10, 2005 at the Naco Elementary School.

Statements by one of the local organizers indicate that the customers are interested in a public forum held in the evening when more customers can attend. The significant demonstration of public interest in the matter warrants conducting a Public Comment meeting in Naco.


IT IS THEREFORE ORDERED that a Public Comment meeting will commence on May 10, 2005, at 6:00 p.m. at the Naco Elementary School gymnasium, 1911 W. Valenzuela, Naco, Arizona.

IT IS FURTHER ORDERED that the hearing originally set for May 10, 2005, shall be continued to May 17, 2005 at 10:00 a.m., or as soon thereafter as is practical, at the Commission's offices, Room 222, 400 W. Congress, Tucson, Arizona.

IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113-Unauthorized Communications) applies to this proceeding as the matter is now set for public hearing.

1 IT IS FURHTER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
2 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


