
Pursuant to Arizona Administrative Code R14-3-105 Sprint Communications Company L.P. ("Sprint") hereby requests leave to intervene in this matter. In support of this request, Sprint states and alleges as follows:

1. Sprint Communications Company, L.P. provides inter- and intraLATA interexchange service throughout the United States and in international commerce and is certified to provide competitive local telecommunications service in several markets in the Qwest region, including Arizona.
2. As an interexchange carrier, Sprint must pay access charges to local exchange carriers such as Qwest, the incumbent local exchange carrier in Arizona.
3. Accordingly, Sprint has an interest in this proceeding, as it will be directly and substantially affected by the decisions rendered by the Commission herein.

WHEREFORE, Sprint requests the Arizona Corporation Commission issue an order granting Sprint leave to intervene and participate in this matter as a full party.


