**EXTRAORDINARY
PROTECTIVE ORDER**

BY THE COMMISSION:

On August 22, 2001, AT&T Communications of the Mountain States, Inc. ("AT&T") filed a Motion for Extraordinary Protective Order. AT&T's Motion came in response to Arizona Corporation Commission ("Commission") Staff's ("Staff") request for a count of loop facilities, broken down by residential and business facilities, owned and operated by AT&T within the State of Arizona ("Confidential Information").

AT&T requested that the Commission issue a Protective Order that the Confidential Information be made available to one (1) attorney per party, or where a party is not represented by an attorney, by the party's representative, and no others.

No party objected to AT&T's request.

IT IS THEREFORE ORDERED that AT&T shall provide the Confidential Information described herein subject to the terms of all outstanding and relative Protective Orders and/or Confidentiality Orders in this matter, incorporated herein by reference, and further subject to the limitation that the Confidential Information be made available to each Commissioner, if requested, one (1) Staff witness, one (1) attorney per party, or where a party is not represented by an attorney, to the party's representative, and no others. Each party or individual that is to review the Confidential Information described herein shall be required to execute a protective agreement with AT&T that incorporates the disclosure limitations set forth in this Order, prior to receipt of the confidential information.

1 IT IS FURTHER ORDERED that the Confidential Information shall not be released to any
2 party who has not heretofore intervened in these proceedings, until further order of the Commission.

3 IT IS FURTHER ORDERED that this Extraordinary Protective Order shall continue in force
4 and effect after this Docket is closed.


