**PUBLIC NOTICE OF HEARING CONCERNING**  
**ARIZONA PUBLIC SERVICE COMPANY'S**  
**CODE OF CONDUCT**

**Docket No. E-00000A-02-0051 et al.**

The Arizona Corporation Commission ("Commission"), in Decision No. 65154 (September 10, 2002) ordered Arizona Public Service Company to submit modifications to its existing Code of Conduct, which, as required by rules adopted by the Commission, addresses procedures, guidelines and policies to govern activities between regulated electric utilities and their competitive electric affiliates for the purpose of preventing anti-competitive activities.

The Commission will hold a public hearing on this matter beginning **November 14, 2005 at 10:00 a.m.** at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona. Public comments will be taken on the first day of the hearing.

The law provides for an open public hearing at which, under appropriate circumstances, interested parties may intervene. Intervention shall be permitted to any person entitled by law to intervene and having a direct and substantial interest in the matter. Persons desiring to intervene must file a written motion to intervene with the Commission no later than **September 16, 2005**. The motion to intervene must be sent to all parties of record, and shall contain the following:

1. The name, address, and telephone number of the proposed intervenor and of any entity upon whom service of documents is to be made if different from intervenor;
2. A short statement of the proposed intervenor's interest in the proceeding; and
3. A statement certifying that a copy of the motion to intervene has been mailed to all parties of record in the proceeding.

The granting of intervention, among other things, entitles a party to present sworn evidence at the hearing and to cross-examine other witnesses. However, failure to intervene will not preclude any interested person or entity from appearing at the hearing and providing public comment or from filing written comments in the record of the case. You will not receive any further notice of this proceeding unless you request it.
