PROCEDURAL ORDER

**BY THE COMMISSION:**

On April 27, 2005, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing ("Notice") against Christopher D. Dedmon and Kimberly Dedmon and Omni Horizon Group, LLC ("Omni") (collectively "Respondents") in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of evidences of indebtedness for shares of stock.

Respondents were duly served with a copy of the Notice.

On May 11, 2005, Respondents filed a request for a hearing. By Procedural Order, a pre-hearing was scheduled for June 7, 2005. Although the Procedural Order indicated that Respondents had filed an Answer, Respondents filed only a request for hearing and should file their Answer within 30 calendar days of the date of receipt of the Notice.

Accordingly, pursuant to A.A.C. R14-4-305, Respondent should file an Answer as stated in the Notice at page seven.




