IN THE MATTER OF THE FILING OF ARIZONA-AMERICAN WATER COMPANY OF AN AFFILIATE AGREEMENT WITH ARIZONA WATER RESOURCES, INC.

PROCEDURAL ORDER

BY THE COMMISSION:

On March 9, 2005, Arizona-American Water Company ("Arizona-American") filed with the Arizona Corporation Commission ("Commission") an Agreement For Support Services Between American Water Resources, Inc. ("AWR") and Arizona American. Arizona-American and AWR are both subsidiaries of American Water Works Company, Inc.

On June 9, 2005, the Commission's Utilities Division ("Staff") and Arizona-American filed a stipulation regarding testimony filing deadlines.

By Procedural Order issued June 10, 2005, the following procedural schedule was established: Staff testimony would be filed by June 15, 2005; Arizona-American testimony would be filed by July 15, 2005; and Staff rebuttal testimony would be filed by August 1, 2005. In addition, a hearing was scheduled for August 10, 2005.

On June 14, 2005, Arizona-American and Staff filed a Stipulation agreeing to a modification of the procedural schedule. The parties requested that the following dates be incorporated into a Procedural Order: Staff testimony would be filed by June 24, 2005; Arizona-American testimony would be filed by July 22, 2005; and Staff rebuttal testimony would be filed by August 5, 2005.

IT IS THEREFORE ORDERED that the following procedural schedule shall be observed for filing testimony in this proceeding:

- June 24, 2005 Staff Testimony
- July 22, 2005 Arizona-American Rebuttal Testimony
- August 5, 2005 Staff Rebuttal Testimony

IT IS FURTHER ORDERED that the August 10, 2005 hearing date, at 1:00 p.m., shall be

1 maintained in accordance with the June 10, 2005 Procedural Order.

2 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113-Unauthorized
3 Communications) continues to apply to this proceeding as the matter is scheduled for public hearing.

4 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
5 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


