PROCEDURAL ORDER

BY THE COMMISSION:

On June 3, 2005, the San Manuel Railway Company ("Railroad") submitted to the Arizona Corporation Commission ("Commission") a request for approval to remove an at-grade public railroad crossing at the San Manuel Airport Access Road in Pinal County, Arizona at AAR DOT No. 916-303S ("Application").

IT IS THEREFORE ORDERED that the request of the Railroad shall be considered an application for the removal of a crossing and for its closure pursuant to A.R.S. § 40-337, et seq.


IT IS FURTHER ORDERED that the **hearing** on the application shall be held on **July 14, 2005, at 10:00 a.m.**, or as soon thereafter as is practical, at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona.


