BY THE COMMISSION:

On April 15, 2005, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing ("Notice") against Mark J. Sheehy and Jane Doe Sheehy ("Respondents") in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with his employment as a registered securities salesman. Jane Doe Sheehy was joined in the proceeding pursuant to A.R.S. § 44-2031(C).

Respondents were served with a copy of the Notice by either certified mail or publication.

On May 31, 2005, Respondent, Terri A. Sheehy, filed a request for hearing and an Answer generally denying the allegations in the Notice. There has been no response filed by Respondent, Mark J. Sheehy.

On June 27, 2005, the parties filed a request to continue the pre-hearing conference while they attempt to settle the proceeding.

Accordingly, the pre-hearing conference should be continued as requested.


