We, the citizens of San Manuel, AZ, are very concerned about the petitions made by Coronado Utilities, Inc. before the Arizona Corporation Commission in your court on June 29, 2005.

We urge, your Honor, to deny said petitions. Please do not allow a change of business regarding the creation of a new sewer treatment plant.

We feel BHP is responsible for noncompliance. They are in violation under Federal, State, and County environmental laws. Please do not allow the change of hands in this matter.

We feel that on behalf of us, the citizens of San Manuel, AZ, legitimate inspection is necessary to prove that violations of noncompliance are present now and have been ongoing with BHP's knowledge.

We also feel, your Honor, that we should not be penalized as citizens; BHP has been operating the sewer treatment plant, not us.

Furthermore, we the citizens of San Manuel, AZ, would like the court's understanding that BHP is responsible for this sewage treatment plant and it's contents, from the "cradle to the grave". We already pay an approximate \$50.00 a year sewer payment. Many of us are on a fixed income. Now Coronado Utilities, Inc. is requesting approximately \$50.00 a month, which comes to \$600.00 a year for a debt we did not incur. How fair is a **1200% increase** in sewage costs?!

Finally, we the citizens of San Manuel, AZ, restate our request--please do not allow BHP to sell the mass acreage and shirk their responsibility onto we, the people.
