Twice in the 29 years that I have lived here we were without for such a long period of time that The Home Owner's Assn and our Fire Dept. (not the water company) went door to door passing out drinking water.

My final comment is: We need another water tank -- God help us if we have a fire and lastly -- we need to have a water company that will care if we are out of water or not.
