United States Advanced Network, Inc. ("Applicant") has filed with the Arizona Corporation Commission ("Commission") a notice of withdrawal of the Certificate of Public Convenience and Necessity to provide Competitive Resold Interexchange Telecommunications Services in the State of Arizona. Under appropriate circumstances, interested parties may intervene in the proceedings, and participate as a party. Intervention shall be in accordance with the A.A.C.R. 14-3-105, except that all motions to intervene must be filed on or within twenty (20) days of the date of this notice. You have the right to intervene in the proceedings, or you may make a statement for the record. If you have any comments, mail them to:


