PROCEDURAL ORDER

16 **BY THE COMMISSION:**

17 On March 2, 2005, Circle City Water Company, LLC ("Circle City" or "Applicant") filed
18 with the Arizona Corporation Commission ("Commission") an Application for Approval of Hook-Up
19 Fee Tariff ("Hook-Up Fee Application").

20 On March 2, 2005, Circle City additionally filed an Application for Extension of Certificate
21 of Convenience and Necessity ("CC&N Extension Application").

22 On March 14, 2005, Circle City Filed a Motion to Consolidate the above referenced dockets
23 based upon the fact that the generic issues relating to its Hook-Up Fee Application are relevant to its
24 CC&N Extension Application such that consolidation would serve the interests of administrative
25 efficiency.

26 On April 4, 2005, the Commission granted Circle City's Motion to Consolidate, after no
27 objections were filed.

28 On July 8, 2005, Gale Graves, filed a Motion to Intervene in these proceedings stating that she
is a residential customer of Circle City and that she has an interest in additional funds to be paid out
by customers and in having an adequate water supply.


No objections have been filed to Gale Grave's Motion to Intervene.


