



**PUBLIC NOTICE OF THE HEARING FOR ENTRADA DEL ORO SEWER
COMPANY FOR A CERTIFICATE OF CONVENIENCE AND NECESSITY**
(Docket No. SW-04316A-05-0371)

On May 24, 2005, Entrada Del Oro Sewer Company ("Applicant") filed an application for a Certificate of Convenience and Necessity to provide wastewater service to a development known as Entrada Del Oro, located in Pinal County, Arizona, approximately 4 miles east of Gold Canyon. If the application is granted, the Applicant would be the exclusive provider of wastewater to the proposed area, and would be required by the Commission to provide service under rates, charges, terms, and conditions established by the Commission. The application is available for inspection during regular business hours at the offices of the Commission in Phoenix, at 1200 West Washington Street, Phoenix, Arizona and at the Applicant's office, Entrada Del Oro Sewer Company, 5010 E. Shea Blvd, Suite A-216, Scottsdale, Arizona 85254.

The Commission will hold a hearing on this matter commencing on **September 16 2005, at 10:00 a.m.**, at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona. Public comments will be taken on the first day of the hearing.

The law provides for an open public hearing at which, under appropriate circumstances, interested parties may intervene. Intervention shall be permitted to any person entitled by law to intervene and having a direct and substantial interest in the matter. Person desiring to intervene must file a written motion to intervene with the Commission, which motion should be sent to Applicant or its counsel and to all parties of record, and which, at the minimum, shall contain the following:

1. The name, address, and telephone number of the proposed intervenor and of any party upon whom service of documents is to be made if different than the intervenor.
2. A short statement of the proposed intervenor's interest in the proceeding (e.g. a customer of the company, a shareholder of the company, a competitor, etc.).
3. A statement certifying that a copy of the motion to intervene has been mailed to the Company or its counsel and to all parties of record in the case.

The granting of motions to intervene shall be governed by A.A.C. R14-3-105, except that all motions to intervene must be filed on or before August 11, 2005. The granting of intervention, among other things, entitles a party to present sworn evidence at the hearing and to cross-examine other witnesses. However, failure to intervene will not preclude any customer from appearing at the hearing and making a statement on such customer's behalf.
