PROCEDURAL ORDER

**BY THE COMMISSION:**

On August 13, 2003, the Arizona Corporation Commission ("Commission") issued Decision No. 66177 which granted Sulphur Springs Valley Electric Cooperative ("SSVEC") revisions to its experimental time-of-use tariffs, including the Residential Time of Use ("RT"), the General Service & Small Power Time of Use ("GT") and General Power Service Time of Use ("PT").

In the Decision, the Commission's Utilities Division ("Staff") was ordered to issue a Staff Report by June 30, 2005, recommending whether the tariff rates should be amended, extinguished or made permanent.

On June 24, 2005, Staff filed a request to extend the June 30, 2005 filing of the Staff Report. Staff indicated that SSVEC needed to file with Docket Control a copy of its annual report pursuant to Decision No. 66177, in order for Staff to prepare its recommendations. Staff requested that it be given 60 days from the date that SSVEC files its annual report to file its Staff Report.

On June 27, 2005, SSVEC filed its annual report.

Staff's request is reasonable, and accordingly, we will extend the time for Staff filing its Staff Report to August 26, 2005.

IT IS THEREFORE ORDERED that Staff shall file its Staff Report no later than August 26, 2005.
