PROCEDURAL ORDER

BY THE COMMISSION:

On April 18, 2005, Santa Rosa Water Company filed with the Arizona Corporation Commission ("Commission") an application for approval to extend its Certificate of Convenience and Necessity ("Certificate") to provide water service to an additional area in Pinal County.

On April 18, 2005, Santa Rosa Utility Company (collectively with Santa Rosa Water Company referred to as "Santa Rosa" or "Applicant") additionally filed an application for approval to extend its Certificate to provide wastewater service to an additional area in Pinal County.

On May 12, 2005, the Commission's Utilities Division Staff ("Staff") filed a letter in both dockets indicating that Santa Rosa's water and wastewater applications have met the sufficiency requirements outlined in Arizona Administrative Code.

On May 25, 2005, Santa Rosa filed a Motion to Consolidate the above referenced dockets.

Staff has indicated that it has no objection to the Santa Rosa's Motion.

IT IS THEREFORE ORDERED that the above-captioned matters shall be consolidated for the purposes of hearing.

1 IT IS FURTHER ORDERED that the hearing in the consolidated matter shall be held on
2 **August 1, 2005 at 10:00 a.m.**, or as soon thereafter as is practical, at the Commission's offices, 1200
3 West Washington Street, Phoenix, Arizona 85007.

4 IT IS FURTHER ORDERED that Staff shall file its Staff Report for the consolidated
5 applications on or before June 27, 2005.

6 IT IS FURTHER ORDERED that the Applicant and any intervenors shall file any objections
7 to the Staff Report on or before July 25, 2005.

8 IT IS FURTHER ORDERED that intervention shall be in accordance with A.A.C. R14-3-105,
9 except that all motions to intervene must be filed on or before July 11, 2005.

10 IT IS FURTHER ORDERED that objections to motions to intervene must be filed on or
11 before July 22, 2005.

12 IT IS FURTHER ORDERED that Santa Rosa shall provide public notice of the hearing in this
13 matter, in the following form and style, with the heading in no less than 10 point bold type and the
14 body in no less than 8 point regular type:

15 **PUBLIC NOTICE OF HEARING ON THE CONSOLIDATED APPLICATIONS**
16 **BY SANTA ROSA WATER COMPANY AND SANTA ROSA UTILITY COMPANY**
17 **FOR AN EXTENSION OF ITS CERTIFICATE OF CONVENIENCE AND**
18 **NECESSITY TO PROVIDE WATER AND**
19 **WASTEWATER SERVICE IN PINAL COUNTY, ARIZONA**

21 On April 18, 2005, Santa Rosa Water Company and Santa Rosa Utility Company
22 (collectively referred to as "Santa Rosa") filed applications with the Arizona
23 Corporation Commission ("Commission") for extensions of their Certificates of
24 Convenience and Necessity ("Certificate") to provide water and wastewater service to
25 certain areas within Pinal County, Arizona. The applications are being consolidated.

26 The applications are available for inspection during regular business hours at the
27 offices of the Commission in Phoenix, at 1200 West Washington Street, Phoenix,
28 Arizona and at the Company's offices, [insert applicants' addresses].

The Commission will hold a hearing on this consolidated matter on **August 1, 2005 at 10:00 a.m.**, or as soon thereafter as is practical, at the Commission's offices, 1200 West Washington, Phoenix, Arizona. As a property owner or customer you may have the right to intervene in the proceeding. If you do not want to intervene, you may appear at the hearing and make a statement on your own behalf. Intervention shall be permitted to any person entitled by law to intervene and having a direct and substantial interest in the matter. Persons desiring to intervene must file a written notice to intervene with the Commission, which motion should be sent to the Applicants or their

1 counsel and to all parties of record, and which, at the minimum, shall contain the
2 following:

- 3 1. The name, address, and telephone number of the proposed intervenor
4 and of any party upon whom service of documents is to be made if
5 different than the intervenor.
- 6 2. A short statement of the proposed intervenors interest in the proceeding
7 (e.g., a customer of the Applicants, a shareholder or member of the
8 Applicants, etc.)
- 9 3. A statement certifying that a copy of the motion to intervene has been
10 mailed to the Company or its counsel and to all parties of record in the
11 case.

12 The granting of motions to intervene shall be governed by A.A.C. R14-3-105, except that
13 all motions to intervene must be filed on or before July 11, 2005. The granting of
14 intervention, among other things, entitles a party to present sworn evidence at hearing
15 and to cross-examine other witnesses. Failure to intervene will not preclude any person
16 with interest in this proceeding from appearing at the hearing and making a statement on
17 such person's own behalf. You will not, however, receive any further notice of the
18 proceeding unless requested by you.

19 If you have any questions or concerns about this application or have any objections to its
20 approval, or wish to make a statement in support of it, you may write the Consumer
21 Services Section of the Commission at 1200 West Washington Street, Phoenix, Arizona
22 85007 or call 1-800-222-7000 or appear at the hearing and make comment.

23 The Commission does not discriminate on the basis of disability in admission to its public
24 meetings. Persons with a disability may request a reasonable accommodation such as a
25 sign language interpreter, as well as request this document in an alternative format, by
26 contacting Linda Hogan, ADA Coordinator, voice phone number 602-542-3931, E-mail
27 LHogan@azcc.gov. Requests should be made as early as possible to allow time to
28 arrange the accommodation.

IT IS FURTHER ORDERED that Santa Rosa shall cause the above notice to be mailed to all
property owners in the proposed service area and published at least once in a newspaper of general
circulation in its service territory, with mailing and publication to be completed no later than June 20,
2005.

IT IS FURTHER ORDERED that Santa Rosa shall file certification of mailing and
publication as soon as practicable after the mailing and publication has been completed but not later
than July 11, 2005.

IT IS FURTHER ORDERED that notice shall be deemed complete upon mailing and
publication of same, notwithstanding the failure of an individual property owner to read or receive
the notice.

1 IT IS FURTHER ORDERED that all parties shall file with the Commission's Docket Control
2 Center, no later than July 25, 2005, a list of witnesses who will testify at the hearing and a description
3 of their area(s) of testimony.

4 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113-Unauthorized
5 Communications) applies to this proceeding as the matter is now set for public hearing.

6 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
7 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


