INSUFFICIENCY LETTER

Dear Sir:

In reference to the above mentioned application filed on April 29, 2005, this letter is to inform you that the application has not met the sufficiency requirements as outlined in the Arizona Administrative Code. The deficiencies are:


1. Please provide the request for service for Parcel J and L.
2. Please provide an estimate of the wastewater facilities costs (for each parcel) necessary to serve the proposed CC&N extension area. The cost should include a description of the major components with the cost of each component (e.g. lift stations, treatment facilities, lineal feet off-site sewage interceptors and collection mains, lineal feet of on-site collection mains, etc.). The method of financing for the major components should be described in as much detail as possible.

Staff would like to use this opportunity to bring the following to your attention:

- Pursuant to the Arizona Administrative Code (“A.A.C.”) R-14-2-411(C), upon meeting sufficiency requirements, the Commission has 150 calendar days for its substantive review. This includes conducting a hearing and preparing Opinion and Order to present to the Commission at an Open Meeting; and
- Pursuant to A.A.C. R14-2-411(C)(3), Staff may terminate an application if the applicant does not remedy all deficiencies within 60 calendar days of the notice of deficiency.
