**STAFF REQUEST TO AMEND  
DECISION NO. 66177 – EXTENSION OF  
TIME TO FILE STAFF'S REPORT**

11 In Decision No. 66177, the Arizona Corporation Commission (“Commission”) ordered  
12 Commission Staff to issue a report with a recommendation as to whether Sulphur Springs Valley  
13 Electric Cooperative (“SSVEC”)’s experimental time-of-use tariffs should be amended, extinguished  
14 or made permanent by June 30, 2005. But that decision also required SSVEC to continue to file  
15 annual reports as described in the decision, including information about how many customers are  
16 taking service under these tariffs, how much those customers have saved relative to SSVEC’s non-  
17 time-of-use rates for the same class of service, and how these tariffs have provided a benefit to  
18 SSVEC. The filing of those annual reports is vital to Staff providing a full recommendation to the  
19 Commission.

20 While SSVEC claims to have filed a copy of its most recent annual report on its experimental  
21 time-of-use tariffs, Staff has no record of it being provided. There is no record of this annual report  
22 being docketed per the docket control database. Because that report is necessary for Staff’s analysis,  
23 Staff believes that an extension of time beyond June 30, 2005, for filing its report is warranted. Staff




