BY THE COMMISSION:


By Procedural Order dated July 29, 2005, a procedural conference was set in the above-captioned matter to commence on August 12, 2005. A scheduling conflict necessitates changing the date and time until August 15, 2005 at 1:30 p.m. The Administrative Law Judge regrets any inconvenience that may result from the change.

IT IS THEREFORE ORDERED that the **Procedural Conference** previously set for August 12, 2005, for the purpose of establishing guidelines in the above-captioned docket shall commence instead on **August 15, 2005, at 1:30 p.m.**, or as soon thereafter as is practical, at the Commission's Tucson offices, **Room 131**, 400 West Congress, Tucson, Arizona 85701.¹

¹ By Procedural Order this same date, the Commission set a procedural conference to commence at the same time in Docket No. W-01646A-05-509 et al, related to consideration of a hook-up moratorium for the McLain water systems. Although the matters of the rate base determination and hook-up moratorium are not being consolidated, the procedural conferences for these matters will be held at the same time in the interest of judicial efficiency.


