PROCEDURAL ORDER

BY THE COMMISSION:

On December 21, 2001, Arizona Corporation Commission Staff ("Staff") filed a Motion to Postpone Final OSS Workshop by one week. Staff states that Colorado has recently scheduled a workshop that conflicts with the Arizona workshop currently set for January 15-18, 2002, and several CLECs will be unable to participate in both proceedings because of the conflict. Staff also states that the parties have reported that with the holidays and overlap of comments and briefs due on Checklist items, they are unable to fully prepare and participate in the final workshop without additional time.

On December 28, 2001, Qwest Corporation filed its Opposition to Staff's Motion. Qwest opposed re-scheduling the workshop because of the added delay. Qwest states the parties had agreed to the January 15 date and have not requested additional time to prepare. Additionally, Qwest requests a schedule for Staff to issue Final Reports and for the Hearing Division to issue Recommended Orders. Qwest requested an expedited procedural conference to address the issues raised by Staff's Motion and its Opposition.

On December 5, 2001, AT&T Communications of the Mountain States, Inc. and TCG Phoenix, (collectively "AT&T") filed a Second Notice of Scheduling Issues.

Qwest filed a Response to AT&T's Notice on December 7, 2001.

In addition, in its December 20, 2001 Special Open Meeting to consider *inter alia* Checklist Item No. 10, the Commissioners requested that the parties supplement the record on the issue of the bulk transfer of CNAM information.

1 IT IS THEREFORE ORDERED that a procedural conference for the purpose of discussing
2 scheduling issues and procedures for supplementing the record for Checklist Item No. 10 shall
3 commence on January 4, 2002, at 1:30 p.m. at the Commission's offices in Phoenix, Arizona.¹

4 IT IS FURTHER ORDERED that the deadline for filing Comments to the Final Report
5 currently set for January 4, 2002, pursuant to Procedural Order dated November 2, 2001, is
6 suspended pending resolution of the scheduling issues.
