## Project Status:

### CLEC Activities

- 4 CLECs have completed SATE testing
- 5 CLECs are currently testing in SATE:
  - A Service Bureau representing 5 CLECs (2 are currently progression testing from 7.0 to 8.0, 3 are currently verifying their trading partner setup).
- One CLEC will begin 7.0 to 8.0 progression testing on 12/17.

### PID

- The revised version of the PID is in discussion in the ROC, all but benchmark is agreed.
- The PID has been presented to Arizona (11/9/01) for discussion and agreement during the SATE workshop in December (12/12); **benchmark discussion tabled until 1/9 TAG meeting.**

### SATE Releases

- Release 8.01 - SATE successfully implemented on 10/22/01; IMA production implemented on 11/19/01
- Release 9.00 - SATE available 1/26/02; IMA production available 2/25/02
- Release 9.01 - SATE availability date is to be determined; IMA production available in April, 2002
- Release 10.00 - SATE availability date will be in May, 2002; IMA availability date will be in June, 2002
- Release 10.01 - SATE availability date is to be determined; IMA availability date will be in August, 2002

### Ongoing SATE Activities

- Implementation of flowthrough in development; Western region available end of 1Q2002; remainder available Mid-May 2002.
- Kickoff for long-term test environment requirements occurred 11/6/01, (this is a collaborative effort between CLECs and Qwest). Additional meetings have been established for 11/13, 11/27, & 12/4.
  - 11/13 meeting held. Mission statement adopted and discussions of CLEC likes and dislikes has begun
  - 11/27 meeting occurred to discuss 'real world test scenarios' and new SATE requirements established in the 11/13 meeting; 4 of 5 CR (change requests) accepted by the group,
  - 12/4 meeting - CRs were finalized and forwarded to CMP for approval in **January meeting**; Each CR was assigned a CLEC 'champion' to participate in clarification meetings
  - 12/11 meeting - VICKI (automated post-order response system to be implemented 1/26/01 with 9.0) white paper reviewed/CLEC questions answered
  - Next meetings are scheduled for 1/08/02, 2/12/02, & 3/12/02
- New version of the IMA EDI Implementation Guide was released on 11/30/01 with SATE updates.
- **SATE Final Report was delivered by HP on 12/21/01. Parties are reviewing/commenting on report by 1/11/02.**
- **Qwest submitted comments to HP's recommendations (from SATE Workshop) on 12/28/01.**
