Page 6, line 21, after "taken."

INSERT: "In addition, we will require the Company to submit pertinent financial information for calendar year 2006."

Page 18, lines 24 through 26

STRIKE: "In the Company's next rate case filing, we expect the intermingling of Company business with non-Company business to be completely eliminated, in regard to both expenses and plant."

INSERT: "We expect the intermingling of Company business with non-Company business, in regard to expenses and plant, to be completely eliminated before the Company's next rate case filing."

Page 19, line 8, after "Company."

INSERT: "We will also require the Company to submit before March 31, 2007 all information identified in A.A.C. R14-2-103 describing the Company's business activities in calendar year 2006, except Reconstruction Cost New (RCN) information and Schedules F, G and H. We will direct Staff to closely examine this information to evaluate the extent to which the Company's expenses and plant additions are for the sole benefit of the Company in its provision of water utility service to the public and the Company is complying with all other requirements of this Decision. As appropriate to the results of its review, Staff shall make a recommendation to the Commission regarding the need for Commission action before the Company's next rate filing. We do not predict the outcome of Staff's review here nor seek to prescribe the range of recommendations that Staff may suggest; however, if the intermingling which was clearly evident in this case persists, we will consider Staff's petition for an Order to Show Cause to be appropriate."

Page 31, line 6, after "followed."

INSERT: "Finally, with the goal of preventing any further improper use of ratepayer revenue, we will also require the Company to submit for Staff review, before March 31, 2007, all information identified in A.A.C. R14-2-103 describing the Company's business activities in calendar year 2006, except RCN information and Schedules F, G and H."

Page 31, line 7, STRIKE "upcoming" INSERT "next"

Page 31, line 10½, INSERT a new Finding of Fact to read:

"In its review of the Company's business information for calendar year 2006, Staff should evaluate the extent to which the Company's expenses and plant additions are for the sole benefit of the Company in its provision of water utility service to the public and the Company is complying with all other requirements of this Decision. As appropriate to the results of its review, Staff shall make a recommendation to the Commission regarding the need for Commission action before the Company's next rate filing."

Re-number to conform

Page 37, line 5, STRIKE "upcoming" INSERT "next"

Page 37, line 8½, INSERT new ordering paragraphs to read:

"IT IS FURTHER ORDERED that Pineview Water Company, Inc. shall submit for Staff review, before March 31, 2007, all information identified in A.A.C. R14-2-103 describing the Company's business activities in calendar year 2006, except RCN information and Schedules F, G and H.

IT IS FURTHER ORDERED that in its review of the Company's 2006 business information, Staff shall evaluate the extent to which the Company's expenses and plant additions are for the sole benefit of the Company in its provision of water utility service to the public and the Company is complying with all other requirements of this Decision. As appropriate to the results of its review, Staff shall make a recommendation to the Commission regarding the need for Commission action before the Company's next rate filing."
