BY THE COMMISSION:

On July 6, 2001, dPi-Teleconnect, L.L.C. ("dPi") filed a Motion to Rescind Decision No. 63587 and Reopen Application, or in the Alternative, to Open a New Docket ("Motion"). This motion requests the Commission to rescind Decision No. 63587 and reopen dPi's application for a Certificate of Convenience and Necessity ("Certificate") to provide competitive resold local and interexchange telecommunications services within the State of Arizona or, in the alternative, to open a new docket to process dPi's application for a Certificate.
