
Dear Mr. Johnson:

Ryland Homes ("Ryland") is the current owner of the Arroyo Vista single-family residential development, located at the southwest corner of Peart Road and McCartney Road in Casa Grande, Arizona. Ryland has been monitoring the Line Siting Committee (the "Committee") "Area B" hearings in the above-captioned matter. It is our understanding that the Committee has recommended that the Salt River Project's ("SRP") proposed 500kv transmission line (the "Transmission Line") be located along a portion of Cornman Road in Casa Grande, which is part of what SRP is referring to as the "Preferred Routing" alternative.
