STAFF'S REQUEST TO SUSPEND  
TIME CLOCK

On March 11, 2005, Tacna Water Company ("Tacna") filed an application to raise its rates. On July 25, 2005, the application was found sufficient. Staff respectfully requests that the time clock on this case be suspended indefinitely. It took Tacna several months to provide Staff the information Staff needed to find that the application was sufficient. Staff has been delayed in its analysis because Tacna has failed to respond promptly to Staff's data requests. Staff anticipates sending out more data requests once Tacna files its first set of responses. In light of the above, Staff believes that it will have difficulty getting the information it needs to process this application under the normal time frames. Even if Staff's request to suspend the time clock indefinitely is granted, Staff will continue to process this application as quickly as possible. Staff has contacted Steve Kelland with Tacna and Tacna has no objection to Staff's request.
