**JOINT STIPULATION FOR EXTENSION
TO FILE ANSWER AND FOR BRIEFING
SCHEDULE**

On July 13, 2005, Pac-West Telecomm, Inc. ("Pac-West") filed the above-captioned complaint against Qwest Corporation ("Qwest) alleging that Qwest has failed to comply with certain terms of the parties' interconnection agreement. Qwest was served with the complaint on July 19, 2005. Since that time, counsel for the parties have conferred and agree that the issues raised in Pac-West's complaint involve primarily questions of law, not factual disputes, and therefore that the matter should be resolved upon expedited briefing and oral argument (in a manner similar to ARCP 56 motions for summary judgment) as opposed to an evidentiary hearing. Accordingly, Pac-West and Qwest hereby stipulate to the following schedule:

- Qwest Answer: Due on Monday, August 22, 2005
- Simultaneous Opening Briefs: Due on Monday, September 12, 2005
- Simultaneous Response Briefs: Due on Monday, October 10, 2005




