PROCEDURAL ORDER

BY THE COMMISSION:

By Procedural Order dated August 2, 2005, the hearing in the above-captioned matters was scheduled to re-convene on September 19, 2005, at the Arizona Corporation Commission's Tucson office. As noted in the August 2, 2005 Procedural Order, the Commission is concerned that the residents affected by the pending applications receive adequate information about the proceeding. The local community has requested that copies of the pleadings be made available at the local library in addition to the Commission's Phoenix and Tucson offices. The request is not unreasonable given the nature and circumstances of this proceeding. Consequently, we will order the parties to provide a copy of all pleadings filed from the date of this Procedural Order forward to the San Manuel Library. The benefit of providing the additional copy outweighs the relatively minor burden on the parties. In addition, the Hearing Division will provide the Library with a copy of relevant documents that have been filed in this matter prior to the date of this Procedural Order.

IT IS THEREFORE ORDERED that from this date forward, in addition to filing with Docket Control, all parties shall provide a copy of any documents they file in this matter to the following address:



13 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.




