PROCEDURAL ORDER

BY THE COMMISSION:

By Procedural Order dated July 27, 2005, the Arizona Corporation Commission ("Commission") established a procedural schedule and set the above captioned matter for hearing.


On August 9, 2005, Las Quintas Serenas Water Company ("LQS" or "Company") and Commission Utility Division Staff ("Staff") jointly requested a suspension of the procedural schedule as they needed additional time to prepare and analyze testimony. This matter involves significant engineering analysis, and the request is reasonable given the Commission's need for a thorough and complete record. No party should be prejudiced by a suspension. After conferring, the parties will present a proposed schedule going forward.

1 IT IS THEREFORE ORDERED that the hearing set to commence on October 26, 2005, is
2 vacated and the procedural schedule established in the July 27, 2005 Procedural Order is suspended
3 pending further Order of the Commission.

4 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 - Unauthorized
5 Communications) continues to apply to this proceeding and shall remain in effect until the
6 Commission's Decision in this matter is final and non-appealable.

7 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
8 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


