BY THE COMMISSION:

FINDINGS OF FACT

1. Far West Water and Sewer, Inc. ("Company" or "Far West") is certificated to provide water and wastewater as a public service corporation in the State of Arizona.

2. On November 14, 2002, the Company submitted revisions to its residential flat rate sewer tariff. The Company is requesting to reduce the approved flat rate charge for residential sewer service from \$20.00 to \$5.00 per month for those customers that during the summer months use water solely for landscaping purposes.

3. According to the Company, the reduced charge would affect approximately 65 percent of customers referred to as "winter visitors" which object to paying for sewer service charges during their absence.


ORDER

IT IS THEREFORE ORDERED that the Company's request for a reduced sewer rate of \$5.00 per month is hereby denied.


IT IS FURTHER ORDERED that this Order shall become effective immediately.
