RE: IN THE MATTER OF COIN PHONE MANAGEMENT COMPANY REQUEST FOR AN EXTENSION OF TIME IN WHICH TO FILE FAIR VALUE RATE BASE INFORMATION FOR A CERTIFICATE OF CONVENIENCE AND NECESSITY TO PROVIDE CUSTOMER OWNED PAY TELEPHONE SERVICE (DOCKET NO. T-03983A-01-0066)

On April 24, 2002, Coin Phone Management Company ("Coin") was ordered to file Fair Value Rate Base information within 18 months of the date the Company first provides service to Arizona customers. Since Coin indicated to the Compliance Section the date that it will begin or has begun providing service, the compliance due date to provide Fair Value Rate Base information was May 4, 2002.

On May 17, 2002, Coin requested an extension of time to provide Fair Value Rate Base information. The extension of time was requested due to a death of a family member. Staff has no objections to Coin's request for an extension of time to file Fair Value Rate Base information. Coin provided Staff the required Fair Value Rate Base information on June 17, 2002.

Staff recommends that Coin be granted an additional forty-five days-retroactive extension to file Fair Value Rate Base information. Staff further recommends that Coin be granted the extension without a hearing. Staff further recommends that all other provisions in Decision No. 63605 remain in effect as ordered.
