PROCEDURAL ORDER

BY THE COMMISSION:

On April 24, 2001, the Arizona Corporation Commission ("Commission") issued Decision No. 63607 which granted Com-Tech Resources, Inc. ("Com-Tech") a Certificate of Convenience and Necessity ("CC&N") to provide customer-owned pay telephone service in the State of the Arizona.

Pursuant to Decision No. 63607, Com-Tech was ordered to file its Fair Value Rate Base ("FVRB") within 18 months from the date it begins providing service<sup>1</sup>.

On October 15, 2001, Com-Tech filed a request for an extension to file its FVRB to comply with Decision No. 63607.

On January 10, 2002, Staff filed a Memorandum stating it had no objection to the request.

IT IS THEREFORE ORDERED that Com-Tech Resources, Inc.'s request for an extension is hereby granted and shall file its Fair Value Rate Base no later than February 11, 2002.


