PROCEDURAL ORDER

BY THE COMMISSION:

On April 1, 1996, Business Discount Plan, Inc. ("BDP" or "Applicant") filed with the Arizona Corporation Commission ("Commission") an application for a Certificate of Convenience and Necessity ("Certificate") to provide competitive resold interexchange telecommunications services, except local exchange services, within the State of Arizona.

On May 4, 2001, the Commission issued Decision No. 63625, which granted BDP its Certificate and ordered BDP to file conforming tariffs within 30 days of the Decision.

On June 27, 2001, BDP filed a request for an extension of time to file those tariffs.

On July 17, 2001, BDP's compliance tariffs were filed.

On July 23, 2001, the Commission's Utilities' Division Staff ("Staff") filed a memorandum stating it has no objection to BDP's request.

Under the circumstances, Applicant's request is reasonable and should be granted.


