IN THE MATTER OF THE APPLICATION OF GO SOLO TECHNOLOGIES, INC. FOR A CERTIFICATE OF CONVENIENCE AND NECESSITY TO PROVIDE COMPETITIVE RESOLD INTRASTATE TELECOMMUNICATIONS SERVICES EXCEPT LOCAL EXCHANGE SERVICE

PROCEDURAL ORDER

BY THE COMMISSION:

On September 19, 2000, Go Solo Technologies, Inc. ("Go Solo" or "Applicant") filed with Docket Control of the Arizona Corporation Commission ("Commission") an application for a Certificate of Convenience and Necessity ("Certificate") to provide competitive resold intrastate telecommunications services, except local exchange service, within the State of Arizona. The Applicant is required to publish notice of its filing in newspapers in all counties where service is to be provided. The record shows that the Applicant has not published notice.

On January 5, 2001, the Commission's Utilities Division Staff ("Staff") filed its Staff Report in this matter.

Pursuant to A.R.S. § 40-282, the Commission may act on an application for a Certificate to provide resold telecommunications services without a hearing, or with a hearing if one is requested by any party.

The time frame for processing this application is June 19, 2001.

Pursuant to Commission rules, the Commission now issues this Procedural Order to govern the preparation and conduct of this proceeding.

IT IS THEREFORE ORDERED that the timeframe for processing the application shall be June 19, 2001.

1 IT IS FURTHER ORDERED that the Applicant shall publish notice, as stated below, in
2 newspapers in every county in Arizona in which Applicant desires to provide service by February 16,
3 2001, and shall file Affidavits of Publication no later than March 9, 2001.

10 Go Solo Technologies, Inc. ("Applicant") has filed with the Arizona Corporation
11 Commission ("Commission") an application for a Certificate of Convenience and
12 Necessity ("Certificate") to provide resold intrastate telecommunications services in the
13 State of Arizona. Applicant will be required by the Commission to provide this service
14 under the rates and charges and terms and conditions established by the Commission.

15 A.R.S. § 40-282 provides that the Commission may act on an application for a
16 Certificate to provide resold telecommunications services without a hearing, or with a
17 hearing, if one is requested by any party. Applicant or any other party must request a
18 hearing within 21 days from the date of this publication, or the Commission will rule on
19 the application without a hearing.

20 The application, report of the Commission's Utilities Division Staff, and any
21 written exceptions to the Staff Report prepared by the Applicant are available for
22 inspection during regular business hours at the offices of the Commission located at 1200
23 West Washington Street, Phoenix, Arizona 85007, and at Applicant [address].

24 Under appropriate circumstances, interested parties may intervene in the
25 proceedings and participate as a party. Intervention shall be in accordance with A.A.C.
26 R14-3-105, except that all motions to intervene must be filed within 21 days from the
27 date of this publication. You may have the right to intervene in the proceeding, or you
28 may make a statement for the record. If you have any comments, mail them to:

9 IT IS FURTHER ORDERED that Go Solo shall file written exceptions, if any, to the Staff
10 Report or a request that a hearing be set by **12 noon** on March 6, 2001.

11 IT IS FURTHER ORDERED that the time periods specified herein shall not be extended
12 pursuant to Rule 6(a) or (e) of the Arizona Rules of Civil Procedure.

13 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend or waive
14 any portion of this Procedural Order by subsequent Procedural Order or by ruling at hearing.
