NOTICE OF APPLICATION FOR A CERTIFICATE OF CONVENIENCE AND NECESSITY TO PROVIDE RESIDUAL INTRASTATE TELECOMMUNICATIONS SERVICES BY TELCORP, LTD.

TELCORP, LTD. ("Applicant") has filed with the Arizona Corporation Commission ("Commission") an application for a Certificate of Convenience and Necessity ("Certificate") to provide residual intrastate telecommunications services in the State of Arizona. Applicant will be required by the Commission to provide this service under the rules, rates, charges and terms and conditions established by the Commission.

A.R.S. § 40-203 provides that the Commission may act on an application for a Certificate to provide residual telecommunications services without a hearing, or with a hearing, if one is requested by any party. Applicant or any other party must request a hearing within 21 days from the date of this publication, or the Commission will rule on the application without a hearing.

The application, report of the Commission's Utilities Division Staff, and any written objections to the Staff Report prepared by the applicant are available for inspection during regular business hours at the offices of the Commission located at 1200 West Washington Street, Phoenix, Arizona 85007, and at TELCORP, LTD., 120 Broadway, Hewlett, NY 11557.

Under appropriate circumstances, interested parties may intervene in the proceedings and participate, as a party. Intervention shall be in accordance with A.C.C. R14-102, except that all motions to intervene must be filed within 21 days from the date of this publication. You may have the right to intervene in the proceeding, or you may make a statement for the record, if you have any comments, that merit it.

All comments should be received within twenty-one (21) days from the date of this publication.



