PROCEDURAL ORDER

BY THE COMMISSION:

On July 14, 2000, CenturyTel Solutions, L.L.C. ("Applicant" or "CenturyTel") filed with Docket Control of the Arizona Corporation Commission ("Commission") an application and petition for a Certificate of Convenience and Necessity ("Certificate") to provide competitive facilities-based and resold intrastate telecommunications services in Arizona.

On May 4, 2001 (Decision No. 63638), CenturyTel was granted a Certificate. Decision No. 63638 required CenturyTel to file a compliance tariff and 911 service information within 30 days of that decision.

On June 5, 2001, CenturyTel filed a request for an extension of time to file its compliance tariff and 911 service information. CenturyTel is requesting that it file such information within 30 days of approval of an interconnection agreement since its interconnection agreement will address such issues.

On June 8, 2001, the Commission's Utilities Division Staff ("Staff") indicated that it has no objections to CenturyTel's request
