FINDINGS OF FACT

13 1. On April 3, 2001, Qwest Corporation ("Qwest") filed tariff revisions to introduce
14 Anywhere Voice Mail.

15 2. Anywhere Voice Mail service would allow a customer to subscribe to Qwest's Voice
16 Mail Service without having to subscribe to Qwest's local exchange service. The service includes
17 Number Forwarding Service a service that Qwest has proposed to introduce in Docket No. T-01051B-
18 01-0282.

19 4. Qwest seeks approval of new offerings under terms of the Price Cap Plan approved by
20 the Commission in Decision No. 63487, dated March 30, 2001. Qwest proposes to include the service
21 as a Price Cap Plan Basket 3 service.

22 5. On May 1, 2001, in Decision No. 63652, the Commission suspended the filing for a
23 period of ninety days. Staff recommended that the filing be suspended because it had not completed
24 its evaluation of the competitiveness of the proposed service. Under the terms of the Plan, Qwest's
25 services are grouped into three Baskets with different levels of pricing flexibility granted to each.
26 Qwest proposes to include the proposed service in Basket 3, giving it the greatest degree of pricing
27 flexibility for a service permitted under the Price Cap Plan.




THEREFORE, IT IS ORDERED that the filing, as amended be and hereby is approved.





